Date for Online Reporting for Provisional Admission: **November 16-21, 2020**

**Due to the pandemic situation arising out of COVID-19, there will be no Physical reporting for admission to B.Tech. at NIT Jamshedpur. All processes would be carried out online only.**

**Candidates who have SECURE the admission at NIT Jamshedpur in ONLINE MODE through JoSAA-2020 web portal are required to complete the following steps for provisional admission in B.Tech.**

**Documents to be uploaded:**

- i. Medical Fitness Certificate should be issued from the registered Medical Practitioners/ Govt. Doctors as per JOSAA format.
- ii. Digital passport size photograph
- iii. Migration or Transfer Certificate from the School/institute last Attended
- iv. JEE (Main) score card 2020
- v. Provisional Seat Allotment Letter /Provisional Admission Letter generated from JoSAA 2020 portal
- vi. Date of birth proof (Class X Mark Sheet/ Date of Birth Certificate)
- vii. Photo identity proof (issued by Govt. agency/Aadhaar/Passport)
- viii. Class XII (or equivalent) board mark sheet and Pass certificate.
- ix. Certificate of category (SC/ST/OBC-NCL/GEN-EWS), **if applicable**, as per Government of India format, available on the JoSAA-2020 website, issued by the competent authority. In case of OBC- NCL/GEN-EWS category, the certificate must be issued on or after April 01, 2020.
- x. Certificate for Persons with Disabilities (PwD), if applicable, issued by the competent authority. Refer JoSAA-2020 website for format. The certificate will be rejected if the disability is less than 40%.
- xi. OCI/PIO card/ Passport, if applicable.

**Note:** If the original certificates are not in English/Hindi, English/Hindi version/translation of such certificates, duly certified by the Principal/Director or other competent authority of the graduating Institute, will be required during the verification of documents.
