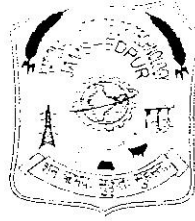
## NOTICE

Attn : ALL STUDENTS

4. A student must intimate his/her absence to the Warden of the hostel in which he/she is residing, before availing of any leave. Failing to do so will be construed as breach of discipline.
5. Furnishing false statement of any kind in the form of application for admission or for award of scholarship, adoption of unfair means in the examinations, etc. attract disciplinary action
6. Organizing or participating in any group activity in company with others, in or outside the campus without the permission of the Dean(Students Welfare) attract disciplinary action.
7. No student shall be involved directly or indirectly in any fighting, gambling, anti social activities, ragging etc.
8. The Students are strictly prohibited from venturing to places viz. Kharkai River/Lake/Pond /PHED Water Tank or similar places.
9. The Students are hereby directed not to indulge in any type of intoxication.
10. The boarders are hereby directed not to keep any motorized vehicle in the Hostel/Institute premises, except the differently abled students.
