The competent has approved the following medicine shop in Jamshedpur for supply of medicine to the institute employees and their dependents. The letter of empanelment is effective from 14.08.2020.

Medicine Shops:

1. M/s. Mani Medicals, Road No.: 04, NIT Road, Adityapur – 2, Dist.: Seraikella-Kharsawan – 831013
2. M/s. REMEDI PHARMA, Tiwari Bechar Complex, Main Road, Bistupur (Near City Style), Jamshedpur – 831001
3. M/s. Sri Balaji Medicals, Main Road Gamaharia, Near HDFC Bank, PO: Gamaharia, Dist.: Seraikella-Kharsawan – 83208

The supply of medicine will be on following terms and conditions:

1. The medicines will be supplied only to Institute employees and their dependents on cashless basis.
2. Supply will have to be made ex-shop directly to the requisition receipt bearer against the submission of authorized signed requisition.
3. Only prescribed brand of medicines will be supplied. Firm cannot deliver change/ alternate medicine.
4. The supply of medicine shall be made on Maximum Retail Price (MRP) basis of respective medicine less 11% discount on Branded Medicines and 30% discount on Generic Medicines. No other charges will be admissible.
5. Printed and pre-numbered requisition receipt duly filled in and signed by the authorized Institute Medical officer will be issued for the supply of Medicine.
6. Instead of cashless basis, supply of the medicine to Institute employees on payment basis directly on submission of NIT Institute Medical Book and the prescription of the doctor of empaneled hospitals on Maximum Retail Price (MRP) basis of respective medicine less 11% discount on Branded Medicines and 30% discount on Generic Medicines.
7. The empanelment of previous shops (i) M/S CITI Medicals, Adityapur, Jamshedpur and (iii) M/S Raja Medical, Bistupur, Jamshedpur is not in existence.
