NOTICE

The New Medical Sevice Book is valid only up to 31st March 2020. Hence, all the employees of this Indtitute are requested to submit the Medical Service Book in the Office of the Establishment Section alongwith the prescribed format duly filled and forwarded by the HODs/HOSs/HOCs by 20th to 25th March 2020 during the 9.00 AM to 12.00 noon and collect the Medical Service Book on the same day. The renewal of Medical Service Book is required to provide smooth medical facilities at all concerned Hospitals.

- 1. The spouse employed may choose either the facilities provided by their organisation in which the spouse is employed or from this Institute.
- 2. The income limit for dependency of the family members (other than spouse) is ₹ 9,000/- per month on the date consideration for the facility.
- 3. For unmarried son: till he starts earning, or attains the age of 25 years, whichever is earlier.
- 4. For daughter: till she starts earning or get married, whichever is earlier, irrespective of age limit.
- 5. Son/Daughter suffering from permanent disability of any kind (Physical or Mental): no age limit.
- 6. Institute employee has to submit a certificate issued by the employer of the spouse in original starting that she/he is not being provided medical facilities from their employer at the time of renewal/issue of medical book or has to submit a undertaking that his/her spouse is not employed.
- 7. The emplyees are also directed to submit an undertaking after attending the age of 18 years of his/her son/daugher, stating that his/her son/daughter is not earning/marriaged as on day.

This may be treated as most urgent.
