All Heads of the Department

We all are aware of the fact that all academic activities of the Institute are closed due to the outbreak of COVID-19 pandemic. Since the students are not in the campus, the Mid semester and End Semester examinations could not be held as per the Academic Calendar for Spring Semester 2019-2020. The normal travel of the students to the campus may not be possible now due to non-availability of public transport like rail.

After due deliberations and discussions in its 30th Senate Meeting held on 4th May, 2020 vide Minutes No. SEN/MIN/30/2020-05/4 it was resolved to conduct online Mid and End Semester examination for 2020 pass out students only i.e. final year students with the following revised

- 1. Mid Semester Examination- 30%
- 2. End Semester Examiantion-40%
- Internal Assessment- 30%

The online Mid semester Examination shall commence from 18-05-2020, which would be MCQ based and for End semester Examination the mode of Online Examination shall be as follows:

Questions for End Semester Examination to be sent by the Course Faculty to all the students registered in their course, on their registered E-mail id and answers to be uploaded in the PDF/JPEG form in the course faculty mail-id or WhatsApp number. Time given to write the answer will be 02 hours and time to upload the answer will be half an hour. The question paper shall bear the mail id and WhatsApp number where the answer has to be uploaded. The questions be designed with the restriction of space and words so as that the total pages do not cross 04 A4 pages. The digital record has to be kept for evaluation and for further needful.

Or

Through Viva-voce examination using any online meeting platform such as CISCO WebEx meeting/Google most Misroon meet cu. The recording of the meeting has to be kept for evaluation and for further needful.

The course faculty is free to use any of these two means for End semester evaluation of

Regarding Viva-voce Examination (Project/ Sessional/ Laboratory) for B.Tech 8th Semester, M. Sc 4th Semester, MCA 6th Semester and M. Tech 4thSemester the mode of Examination shall be Online using any online meeting platform such as CISCO WebEx meeting/Skype /Google meet/Microsoft meet etc. The students shall submit the Project Report in PDF Format to the Concerned Supervisor through online and it will be accepted for evaluation.
