Sir,

With reference to above cited subject, I am directed to inform you that your tender has been accepted for providing services in ANNAPURNA CAFETERIA at NIT Jamshedpur under the following terms and conditions.

1. Period of contract is for three years subjected to its assessment of annual performance and mutual agreement on rate and discount on annual basis. The extension of the contract will entirely depend upon your performance and feedback from the students and Committee of Campus Retail Services (CCRS).
2. Cafeteria services have to be provided to the students and staff of the institute as per the menu and quality of ingredient and to accept all terms and conditions mentioned in the tender document.
3. Maintenance/AMC of all the appliances/accessories, furniture, fixture & fittings related to Civil and Electrical will be done with your own cost and arrangement without altering the make/brand of provided items.
4. Purified water for drinking and cooking has to be provided with your own arrangement and cost.
5. The final rate items will be the rate mentioned in the menu with the rebate you have offered in the financial bid i.e. inclusive of all taxes.
6. The quality of food shall in no way be compromised. Your performance will be closely watched by CCRS members. In case of Deficiency in quality of food and services, suitable penalty will be imposed in terms of monetary fine or termination of contract on the recommendation of CCRS with the approval of competent authority.
7. Performance security in form of Bank Guarantee of Rs. 2, 50,000/- (Rupees Two Lakh Fifty Thousand) only are to be submitted, in favor of National Institute of Technology Jamshedpur within fifteen days, which will remain in the institute for a period of three years and the same will be returned on successful completion of the contract.
8. At the end of every month you have to pay license fee, electrical and water charges mentioned in tender document and submit the copy of all the statutory payment made by you for your employees.
9. Terms and Conditions, Scope and Limitations of the work as per the list of menu and your percentage of rebate on items mentioned in the list will remain valid and will be the part of MoU/Agreement.
10. All disputes in this regard are subjected to the jurisdiction of Seraikela-Kharsawan Court.
11. Kindly acknowledge the receipt of this letter in form of expression of interest and complete the contract agreement on the non-judicial stamp paper of Rs. 100/- (Rupees One Hundred only) and submit it within one week.

In view of above, you are requested to visit NIT Campus and initiate necessary arrangements for start of Annapurna Cafeteria and its Kitchen as early as possible.
