The **B.Tech. 2023, 2024, 2025 batch students** are requested to submit the applications for claiming the **tuition fee remission** based on their family income. As per the Government rules, the **UNRESERVED/OBC/EWS students are eligible** to get the benefits of fee remission if the family income is as mentioned below:

- i Most economically backward students (whose total family **Income below 1 Lakh per annum**, maximum allowable up to Rs.99,999/-) will be **eligible for full fee remission**.
- ii Other economically backward students (whose total family **Income between 1 lakh to 5 Lakhs**, maximum allowable up to Rs.4,99,999/-) will be **eligible for 2/3rd fee remission**.
- iii Fee Remission is **not applicable for SC/ST/PH students**.

The applications are required to be filled up through **hard copy as well as the Google form**. The details of
