In 1999, Shri T Krishna Prasad, an Engineer and an MBA from IIMA, was specially selected by the then Chief Minister Shri Nara Chandra Babu Naidu to build infrastructure and also bring FDI into the State, as well. He was posted as Executive Director Infrastructure Projects in APIIC (Andhra Pradesh Industrial Infrastructure Corporation).

Though an uphill task, by virtue of detailed planning, proper Project Structuring 17 mega Infrastructure projects were designed, DPRs were prepared, Bid Process Management was meticulously conducted, Financial Closures were achieved and finally the projects were built under Public Private Partnership successfully, in record time.

VIZAG INDUSTRIAL WATER SUPPLY PROJECT

In 1999, Vizag was buzzing with lot of industrial projects such as Vizag Steel Plant, NTPC, Pharma City, Refineries etc. However, there was no sustainable water supply to cool the Blast Furnace and Cooling Towers etc. A special Rs 453 Cr project was designed to lift 5 TMC water from river Godavari and another 5 TMC from Yeleru and transfer 520 MLD water through combination of pipes and canals, some open and some through tunnels in the hills, over a distance of 165 kms.

Thus, Sri T Krishna Prasad is not only a Visionary but also a Planner, Executer and a sustainable Monitor and Evaluator.

Apart from constructing the right infrastructure projects that were to be the Drivers of Economy in years to come, it was essential to have the appropriate and enabling policies in place for the private sector to thrive and to set a congenial atmosphere for the economy to surge. Shri T Krishna Prasad envisaged the right areas and actively involved himself in conceptualization, drafting and enabling the following Bills:

- 1) AP Industrial Policy 2000
- 2) AP Information Technology Policy 2000
- 3) AP Infrastructure Development Enabling Act 2001 and gave the first draft for the India's Special Economic Zone Act 2005.

ROAD SAFETY SPECIALIST

Anti Naxal Operations

He personally participated in anti-naxal operations as ASP Kamareddy, Addl SP Nizamabad, SP Medak, SP Visakhapatnam, DIG Warangal, IG greyhounds. As a result of the combing operations, three (3) armed squads were completely decimated and weapons seized.

Three Tent program and Sanjeevani

However, he followed a strong line of thought and principle that a socio-economic movement is best eliminated with solutions that are more oriented with surrenders and economic rehabilitation as against pure Law and Order approach.

In Vizag agency, he conceptualized and implemented an innovative program of Three tent program in which more than 400 medical camps were conducted and about 100 militants were surrendered and rehabilitated and given opportunity to lead normal life. It had an excellent impact and the naxals completely left the district and vacated.

Encouraged by the success in Vizag agency, he conducted Sanjeevani programs in the 4 (four) districts of Adilabad, Karimnagar, Warangal and Khammam as DIG Warangal and conducted a massive ‘‘surrender drive’’ with a missionary zeal that resulted in surrender of nearly 300 naxalites and some of them surrendered with weapons. Yet again, as a sequence, the naxals had to evacuate North Telangana and retreat to Madhya Pradesh and Chattisgarh. Thus, Telangana became free of Naxalites in 2004 itself.

CCTNS

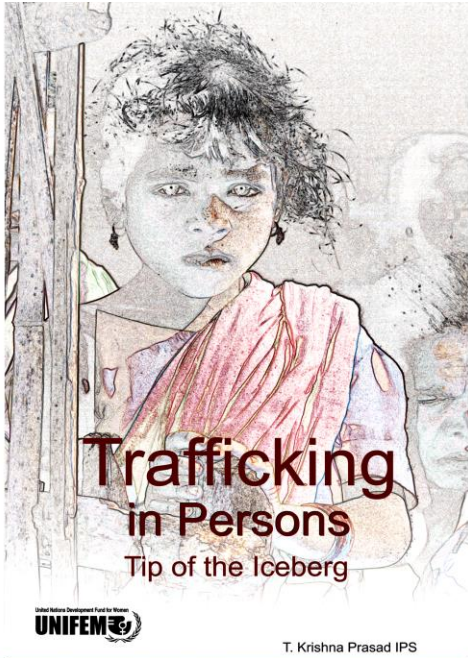
As IG Police Computer Services, he brought all the 1865 Police Stations of AP State, online, as early as Dec 2009. Government of India appointed him as the Chairman for the National Technical Evaluation Committee to select the Application Developer for CCTNS, which he has successfully executed. As a result, today all the police stations in the entire country are now operating on one single platform thereby making sensitive and critical data accessible, particularly about criminals, at the touch of a button across the country.

I/c Director APPA

In 2006, He did firsthand research into the traumatic conditions of children and women subjected to Trafficking. He went back to the villages from where the victims were trafficked from and conducted a detailed analysis of Causative factors, vulnerability issues and the Traffickers. At the time of the research there were 30 crore children in India having no access to school education and therefore were vulnerable to trafficking and were up for grabs for the Traffickers. He finally concluded that Free and Compulsory Education is the critical need of the hour and Right to Education Act should be passed without any delay.

- He approached the Chief Justice of India, President of India and Prime Minister and requested for the Right to Education Act which was finally passed in 2009. The impact is humongous Enrollment into secondary school has increased by 20% by the year 2015.
- While at AP Police Academy as i/c Director, he conducted sensitization courses and trained 4350 Police Personnel Including SHOs/Inspectors and SDPOs on Human Trafficking.
- He conducted the first ever Training Needs Analysis and redesigned the training courses for Sub Inspectors, Inspectors and Dy SPs, on Case Study methodology.

As CMD Leather Industries Development Corporation of AP, he got as many as 1,62,000 leather artisans upskilled to become micro entrepreneurs and he acquired 5,000 acres for the Leather Clusters in the then combined State of Andhra Pradesh.

Unfortunately, due to vote-politics, few political parties who were in power, from 2004 onwards, ignored madiga community and gave them step motherly treatment. As a result, not a single madiga out of 1,62,000 trained leather artisans were given land in the 5000 acres of land. Madigas became orphans. Madigas were wronged. They are, now, very much hurt, frustrated, and angry.

In such a scenario, he started a massive people's movement called MALUPU. People's movement to motivate and encourage madigas to Skill themselves and take to Economic Empowerment leveraging the Government of India schemes like Skill India, Make in India, Mudra Bank etc.

BEYOND THE CALL OF DUTY

In 2019, while still in service, he has started a Peoples movement for Economic Empowerment on the lines of Skill India and Make in India for the BPL families of Marginalised sections.

He started touring districts Telangana and AP and appealed to the SC intellectuals that having enjoyed the benefits of reservation, it is time that the intellectuals should Pay-back-to-Society by participating in promotion of Economic Empowerment of Youth. He also met youth from downtrodden sections and appealed to them that Skilling and MSME is the decisive and ultimate path towards Economic Empowerment.

Intellectuals and youth started storming him, wherever he went. As a result, a new organization by name MALUPU (a Telugu word for Turning Point / *Parivartan* in Hindi) got instituted as a section 8, Not for Profit Organization.

Malupu is today a 25,000 strong youth with more than 1000 MSMEs registered on Udyam on the inspiration of the Atma Nirbhar Abhiyaan - a clarion call given by our beloved and honorable Prime Minister Shri Narendra Modiji.

Malupu has strong organizational framework with State Committees, District Committees in Telangana and AP.



Malupu Societies are already formed in districts like Warangal, Karimnagar. More and more Malupu Societies are being formed. Youth from these Malupu societies have registered on Udyam portal and have uploaded their project Reports on PMEGP portal.

Malupu has a target of promoting 1 lakh MSMEs with an average capital investment of Rs 10 lakh each and cumulative turnover of Rs 5000 crores by 2025.

KP Foundation

While in service, Shri T Krishna Prasad went beyond the call of Duty and adopted Yerravalli village and did yeomen service in the areas of Girl Child Education and Skill Development and donated 42 bicycles to girl children to pursue education. His village adoption and transformation model has taken shape of institution in the name form of KP Foundation, a section 8, Not for Profit Company, and is spread over aspirational districts of Warangal, Vikarabad, Gadchiroli, Vizianagaram and Kadapa. KP Foundation is emerging into a powerful aggregator platform with retired IAS officers and IIMA batchmates as Advisors and Mentors.



During the second wave of Covid pandemic in early 2021, it was unfortunate that India lost few lakhs of lives for want of oxygen and ICU beds. At this time, KP Foundation and American India Foundation collaborated and worked relentlessly, day and night in donating 26,000 oxygen ventilators and constructing 23 one hundred bedded hospitals in the States of Uttar Pradesh, Madhya Pradesh, Karnataka, Andhra Pradesh etc.



In 2023, KP Foundation conducted a highly successful event, titled Digital Pathashala, which aimed to raise digital literacy and awareness among individuals in

several districts across India. The KPF Digital Patashala event was a resounding success, with more than 1,20,000 individuals, mostly SCs and STs in aspirational districts of Nandurabar, Gadchiroli, Warangal, Vizianagaram, Visakhapatnam, Kadapa etc. The program aimed to empower people to navigate the digital world safely in the digital era particularly with the fast spreading with JAM (Jandhan-Adhaar-Mobile phone).
