Sir / Madam,

As you may be aware, all common use goods and services available on Government e-Marketplace (GeM) platform have to be procured by Ministries / Departments and its allied organizations mandatorily from GeM platform. The procurement through GeM platform for such goods and services is monitored by a Standing Committee on GeM headed by JS&FA, Ministry of Education (MoE) at periodic intervals and the same is also being monitored on real time basis by GeM through a dedicated dashboard on their platform.

2. As per the data furnished by GeM, during the FY 2022-23, the total procurement spend by MoE and its allied organizations through GeM portal was of the order of Rs. 3251.47 crores, which translates to 84% of purchase of goods and services by the above organizations. The target is to progressively achieve 100% procurement of all goods and services as required by all Government Organizations through GeM. It is noted that there is still an element of non-GeM based procurement of goods and services and the list of such items is being aggregated so that the same could be onboarded on the GeM platform to achieve the target of 100% procurement.

3. Similarly, data is also required for works which are currently executed through bids floated on non-GeM platforms so that a view could be taken to onboard such facility as well through GeM platform.

4. In this regard, two sets of information are required to be uploaded in consolidated form on behalf of this Ministry and its allied Organizations on the GeM portal as given below: -

- (i) Proforma 1 - Total value of Work, Services and Goods procured - FY 22-23 (actual) and FY 2023-24 (planned)
- (ii) Proforma 2 - Breakup of Goods & Services procurement (in INR crores) done during FY 2022-23. Procurement done outside GeM along with reasons and procurement planned outside GeM in FY 2023-24

5. All BHs of MoE are requested to arrange to provide the information as per proforma 1 and 2 in respect of organizations under their control in a compiled form latest by 25th May, 2023 for uploading on dashboard of GeM portal for the first quarter of current FY (2023-24) and succeeding quarters.
